

Miyaghiaway – Video Submission Terms & Agreement

Owner and Operator: Miyaghiaway

Location: Australia

1. Introduction

Welcome to Miyaghiaway ("Miyaghiaway," "we," "our," or "us").

These Terms apply to anyone ("Creator" or "Participant") who submits video content to Miyaghiaway.

Miyaghiaway allows creators to submit original videos of eligible public locations from Australia or around the world for possible use on the Miyaghiaway website, social media platforms and promotional content.

This is not a competition.

There is:

- No public voting
- No weekly winner
- No voting system
- No guaranteed payment for submitting a video

Creators submit videos for Miyaghiaway to review.

If Miyaghiaway likes a video, approves it and chooses to use it, the Creator will be contacted and offered **AU\$300 for the accepted video**, subject to these Terms.

By submitting a video, you confirm that you have read, understood and agreed to these Terms.

2. Age & Eligibility

You must be **18 years of age or older** to participate in the Miyaghiaway video submission program.

People under 18 are not eligible to submit videos for payment under this program.

By submitting a video, you confirm that:

- You are 18 years or older.
- The information you provide is accurate.
- The submitted video belongs to you.
- You have the legal right to submit the video.
- You can receive payment through PayPal.

Miyaghiaway may request reasonable information to confirm eligibility where necessary.

3. What Videos Can Be Submitted?

Creators may submit videos showing eligible public locations.

Examples may include:

- Beaches
- Parks
- Mountains
- Forests
- Waterfalls
- Lookouts
- Walking trails
- Public gardens
- Natural attractions
- Other publicly accessible locations approved by Miyaghiaway

Locations can be in **Australia or anywhere around the world.**

The location should generally be somewhere people can visit, explore or learn about.

Miyaghiaway may reject any location that does not fit the purpose of the platform.

4. Video Requirements

Submitted videos should:

- Be approximately **30 seconds long**
- Be original footage created by you
- Clearly show the location
- Be good visual quality
- Show reasonable effort in filming and editing
- Be suitable for a general audience

- Not contain unauthorised copyrighted material
- Provide an accurate representation of the location

Videos do not need to be professionally produced.

However, Miyaghiaway is looking for videos that show **quality, creativity and effort**.

5. Where to Submit

Videos must be submitted through the official submission form available on the:

MiyaghiNews page of the Miyaghiaway website.

Creators may be asked to provide:

- Place name
- Location or area
- Address, where applicable
- Postcode
- State, territory, province or region
- Country
- Email address
- Video file or approved video link
- Optional social media information

Creators should check the locations already listed on the Miyaghiaway website before submitting.

Videos of locations already featured may be rejected.

More information about current video requirements can be found on the Miyaghiaway website.

6. How Selection Works

After a video is submitted, Miyaghiaway will review it.

Miyaghiaway may consider:

- Video quality
- Effort
- Editing
- Location
- Originality
- Accuracy

- Whether the location is already on the website
- Whether the content fits Miyaghiaway
- Copyright and ownership requirements

Submitting a video **does not guarantee that Miyaghiaway will select it.**

There is no voting process.

Videos are selected directly by Miyaghiaway.

If Miyaghiaway wants to use your video, we will contact you using the email address you provided.

7. AU\$300 Payment

If Miyaghiaway selects and accepts your video, the payment will be:

AU\$300 per accepted video

Payment will currently be made through:

PayPal only.

You must provide correct PayPal payment information when requested.

Miyaghiaway is not responsible for problems caused by incorrect information provided by the Creator.

International Creators should understand that PayPal or another financial institution may apply:

- Currency conversion
- Transaction fees
- International transfer fees
- Other third-party charges

The amount received in another currency may therefore be different after conversion or third-party fees.

Creators are responsible for any personal tax or reporting obligations that may apply to money they receive.

8. Submission Does Not Guarantee Payment

Uploading a video does not mean Miyaghiaway has purchased it.

A Creator is only eligible for the AU\$300 payment when:

1. Miyaghiaway reviews the video;
2. Miyaghiaway chooses to accept the video;
3. Miyaghiaway contacts the Creator; and
4. The video meets the requirements of these Terms.

Rejected or unselected videos will not receive payment.

9. Original Content & Copyright

Creators must submit their **own original work**.

By submitting a video, you confirm that:

- You created the footage.
- You own the video or have the legal authority to submit it.
- You have the necessary rights and permissions.
- The video does not contain stolen footage.
- The video does not contain unauthorised copyrighted material.
- You have permission to use any music, graphics, photographs or other third-party material included in the video.

Miyaghiaway may request reasonable evidence that a video belongs to you.

This may include:

- Raw footage
- Original video files
- Editing project files
- Licence information
- Permission documents

If ownership cannot reasonably be verified, Miyaghiaway may reject the video or pause payment while the issue is investigated.

10. Music & Third-Party Material

Do not include music, footage, graphics, photographs or other material unless you have the right to use it.

Music available through social media platforms does not automatically mean it can be used by Miyaghiaway on other platforms.

Creators are responsible for making sure their submitted content does not infringe another person's intellectual property rights.

11. Filming Permission

Creators are responsible for checking whether they are allowed to film at a location.

Some locations may require permission or a commercial filming permit.

Creators must:

- Follow local laws.
- Follow signs and location rules.
- Respect restricted areas.
- Not trespass.
- Obtain permission where required.
- Follow instructions from councils, park authorities, property owners or other authorities.
- Respect the natural environment.

Do not enter closed, dangerous or prohibited areas simply to create a video for Miyaghiaway.

12. Safety

Creators participate voluntarily and are responsible for their own travel and filming decisions.

Do not place yourself or another person in danger for the purpose of recording a submission.

Creators should consider:

- Weather
- Track conditions
- Water conditions
- Cliffs
- Wildlife
- Road conditions
- Location closures
- Emergency warnings
- Local safety advice

No video is worth risking your safety.

13. Drone Footage

Drone footage may be submitted where the Creator is legally permitted to record it.

Creators using drones are responsible for following all relevant:

- Aviation requirements
- Airspace restrictions
- Registration requirements
- Location rules
- Park rules
- Privacy requirements
- Permissions

Miyaghiaway may reject drone footage if there are concerns about how it was recorded.

14. People Appearing in Videos

Location videos should primarily focus on the location.

Creators should avoid making unrelated members of the public the main subject of the video without permission.

Where permission or a release is legally required, the Creator is responsible for obtaining it.

Additional care should be taken when children appear in footage.

Miyaghiaway may edit, blur, crop or reject footage where privacy concerns exist.

15. Rights During Review

Submitting a video gives Miyaghiaway permission to:

- Receive the file
- Store the submission
- View the submission
- Review the submission
- Contact the Creator about the submission

Submitting a video alone does **not** mean Miyaghiaway owns the video.

If Miyaghiaway does not accept the video, Miyaghiaway will not publicly use the rejected video unless separate permission is given.

16. Rights for Accepted Videos

If Miyaghiaway accepts the video and pays the Creator AU\$300, the Creator grants Miyaghiaway a:

Worldwide, perpetual, non-exclusive licence

to use the accepted video.

This includes the right to:

- Publish
- Display
- Reproduce
- Edit
- Crop
- Resize
- Shorten
- Add captions
- Add music
- Add voice-over
- Add Miyaghiaway branding
- Add graphics
- Include the video in compilations
- Use clips from the video
- Promote the video
- Advertise Miyaghiaway using the video
- Upload the video to social media
- Display the video on the Miyaghiaway website
- Store and archive the video
- Use the video on future Miyaghiaway platforms

The Creator continues to own their original copyright unless a separate written agreement states otherwise.

The licence is **non-exclusive**, meaning the Creator may continue using their own video.

The AU\$300 payment is the agreed compensation for the accepted video and the usage rights granted under these Terms.

17. Editing Accepted Videos

Miyaghiaway may make reasonable changes to accepted videos so they fit different platforms and content formats.

Changes may include:

- Shortening footage
- Rearranging clips
- Cropping footage
- Adding music
- Adding narration
- Adding text
- Adding captions
- Adding logos
- Adding graphics
- Changing the video format

Miyaghiaway will not intentionally edit a Creator's video in a way designed to falsely represent the Creator or location.

18. Creator Credit

Creator credit is **optional**.

When submitting a video, Creators may provide a:

- Instagram account
- TikTok account
- Facebook account
- YouTube account
- Other social media profile

If provided, Miyaghiaway may credit the Creator alongside the video.

For example:

Video created by: @CreatorName

Creators who do not want public credit do not need to provide social media information.

Providing social media information does not guarantee followers, views, promotion or engagement.

19. Content Standards

Submitted videos must not contain:

- Hateful or discriminatory content
- Explicit sexual material
- Graphic violence
- Illegal activity
- Harassment
- Threats
- Dangerous behaviour encouraged for entertainment
- Stolen content
- Deliberately misleading information
- Content unsuitable for a general audience

Miyaghiaway may reject or remove content that does not meet these standards.

20. Fraud & Misrepresentation

Creators must not:

- Submit another person's video as their own.
- Submit stolen footage.
- Provide false personal information.
- Provide false location information.
- Falsify permits or licences.
- Falsely claim ownership.
- Manipulate evidence of ownership.
- Submit the same content under different identities in an attempt to receive multiple payments.

Fraudulent submissions may be rejected and the Creator may be restricted from making future submissions.

21. Withholding Payment

Miyaghiaway may temporarily withhold payment where there is a genuine concern relating to:

- Copyright
- Ownership
- Fraud
- Identity
- Required permission
- Legal compliance

- Submitted information

Miyaghiaway may request reasonable evidence to resolve the issue.

If the video is confirmed to meet the requirements, payment can proceed.

If the Creator cannot establish the necessary rights or eligibility, Miyaghiaway may reject the submission.

22. No Employment Relationship

Submitting or selling a video to Miyaghiaway does not make the Creator an employee of Miyaghiaway.

Acceptance of one video does not guarantee:

- Future work
- Future payments
- Future video acceptance
- Regular employment
- A partnership with Miyaghiaway

Creators independently choose whether they want to create and submit videos.

23. Location Information

For accepted videos, Miyaghiaway may publicly display information about the location, including:

- Place name
- City or area
- State or region
- Country
- Description
- Travel information
- Relevant location information

Miyaghiaway may conduct its own additional research before publishing a location.

24. Travel Disclaimer

Information provided by Miyaghiaway about locations is for general informational, entertainment and promotional purposes.

Locations and conditions may change.

Changes may include:

- Closures
- Weather
- Access
- Walking tracks
- Entry requirements
- Opening hours
- Fees
- Safety warnings
- Rules
- Restrictions

Visitors are responsible for checking current conditions before travelling.

Miyaghiaway does not guarantee that every location will always remain open, accessible or safe.

25. Limitation of Liability

To the extent permitted by law, Miyaghiaway is not responsible for losses or problems caused by circumstances outside its reasonable control, including:

- PayPal processing delays
- Currency conversion
- Third-party transaction fees
- Banking delays
- Social media platform issues
- Creator copyright violations
- Creator breaches of filming rules
- Unauthorised filming
- Trespassing by a Creator
- Injuries occurring while a Creator independently travels or films content

Nothing in these Terms is intended to exclude any rights that cannot legally be excluded under Australian law.

26. Privacy

26.1 Information We May Collect

Miyaghiaway may collect:

- Name
- Email address
- Age confirmation
- Location information relating to the submitted place
- PayPal payment information necessary to send payment
- Optional social media information
- Submitted videos
- Submission details
- Communications relating to the submission

Miyaghiaway will **never ask for your PayPal password**.

26.2 How Information Is Used

Information may be used to:

- Review submissions
 - Contact Creators
 - Verify submissions
 - Verify ownership
 - Process payments
 - Provide Creator credit
 - Publish accepted content
 - Prevent fraud
 - Respond to legal or support enquiries

26.3 Sharing Personal Information

Miyaghiaway does not sell personal information.

Information may be provided to services necessary to operate the platform, such as:

- Payment providers
- Website providers
- File storage providers
- Professional advisers

Information may also be disclosed where required or authorised by law.

26.4 Storage & Security

Miyaghiaway will take reasonable steps to protect personal information against:

- Loss
- Misuse
- Unauthorised access
- Unauthorised disclosure

Information may be retained where reasonably necessary for payment records, legal requirements, disputes or operation of the program.

26.5 Privacy Requests

Creators may contact Miyaghiaway regarding access to or correction of personal information held about them, subject to applicable law.

Deleting personal information does not automatically cancel rights already granted for an accepted and paid video.

27. Website Use

Users must not:

- Attempt unauthorised access to Miyaghiaway systems.
- Damage or interfere with the website.
- Upload viruses or harmful files.
- Misuse submission forms.
- Impersonate another person.
- Copy another Creator's content without permission.
- Use Miyaghiaway for fraudulent activity.

Miyaghiaway may restrict access where serious misuse occurs.

28. Removal of Published Content

Miyaghiaway may remove accepted content from its website or platforms where reasonably necessary, including because of:

- Copyright claims
- Privacy concerns
- Safety concerns
- Legal requirements
- Platform rules
- Incorrect location information
- Other legitimate operational reasons

Removal of an accepted video does not automatically require the Creator to return payment already properly made unless fraud or another separate legal basis applies.

29. Changes to These Terms

Miyaghiaway may update these Terms as the video submission program develops.

The latest version will display the date it was last updated.

Updated Terms generally apply to new submissions made after the updated Terms are published.

Rights already granted for videos previously accepted and paid for continue under the agreement applying when those videos were accepted unless otherwise agreed.

30. Owner & Operator

The Miyaghiaway platform and this video submission program are:

Owned and operated by Miyaghiaway.

Miyaghiaway manages:

- Video submissions
- Video selection
- Creator communication
- Payments
- Website publication
- Creator credits
- Platform content
